Stephen,

We are aware that you have a hearing coming up this week for the Castlerock project. The applicant was able to submit all the revised documents and project plans to CDFW as of June 10th. And now that CDFW has reviewed the majority of their current and updated project plans and documents, we wanted to provide you with a summary of our review.

- CDFW is satisfied with the overall site plan in regards to the mapping of all watercourses and project setbacks from these features.
- We will begin drafting their streambed alteration agreement soon (it is due to them no later than August 7th). Most of the CDFW concerns will be addressed via mitigation measures contained in the streambed alteration agreement. This includes addressing: the proposed maintenance of their stream crossings; well impacts (for irrigation uses) on the adjacent river and riparian habitat; the habitat restoration activities that will be occurring in the setback area between the S. Ynez River and Cultivation Area A; and, ensuring all watercourse setbacks are implemented.
- They will be pursuing, as a separate process from the streambed alteration agreement, 'take' authorization from CDFW for potential impacts to CA tiger salamander. CDFW is going to confer soon with the USFWS and determine if there is the need for the applicant to obtain take authorization from CDFW. However, based on similar projects, this will likely be the case and it would be beneficial if there were requirements to obtain this take authorization from CDFW, for example, prior to implementation of cultivation activities.
- The only other comment I have at this time is in regards to the numerous groundwater wells they have at the property. They state they have a total of

5 wells and only 3 of them are active (according to their project description). They only provide information for the wells which will be used for irrigation. I am not sure if SB Co. Public Health Department will require that their other active/inactive wells that are not permitted with the county obtain permits? Or if the county would require the wells that are not active to be capped? I know they are using this time to permit existing structures so felt it may be worthwhile to mention it.

Other than the above, CDFW has no other comments to provide you with in regards to our review of their proposed project. Feel free to contact me to if you have any questions or comments regarding this correspondence.
