Good morning Santa Barbara Board of Supervisors,

My name is Brooke and I am the Community Organizing Manager at Climate First: Replacing Oil & Gas, or CFROG. I am here today, like many others, speaking on item #3 to urge you to deny Sable's application to transfer permits for the Santa Ynez Unit, Las Flores Pipelines, and onshore processing facilities.

You have heard the significant concerns from dozens of community members, youth, student leaders, and stakeholders. As elected officials, it is your duty to listen to the people who elected you, not corporate interests.

Sable offshore has shown, time and time again, that they have no respect for our laws, and no interest in complying with them. From numerous cease and desist orders, to an 18 million dollar penalty, to 21 criminal charges – this company has shown a complete disregard for accountability in their relentless pursuit of profit. And in a time where this behavior is not only enabled, but praised, it is imperative that our elected bodies stand firm to protect communities from reckless companies like Sable.

The evidence is clear: Sable is not financially equipped for another oil spill, as seen by their falling stock prices. Sable assumes they are above the law, despite the many violations they've acquired from nearly every decision-making body involved in this issue. And Sable does not act in good faith, which is evident in their efforts to avoid any sense of accountability, transparency, or responsibility. The decision before you is a simple one. Will you deny the permit transfer and stand firm with your communities against reckless corporations? Or will you set a precedent that this board enables corporate greed by putting profit before people? I urge you to choose the former. Thank you.
