WHEREAS, the Code of Santa Barbara County, California, Section 23-11, authorizes the Board of Supervisors of the County by Resolution, to designate parking restrictions on portions of roads and highways under its jurisdiction; and

WHEREAS, it is in the best interest of public safety that certain portions of County streets or highways in Santa Barbara County be designated with parking restrictions and permit parking, in accordance with said Section; and

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as:

No Parking Zones

- On the east side of El Bosque Road, from the centerline of State Route 192/East Valley Road to a point 174 feet north of the centerline of State Route 192/East Valley Road.
- On the west side of Cieneguitas Road from a point 95 feet south of the centerline of Via Andorra to a point 186 feet south of the centerline of Via Andorra.
- On the west side of Cieneguitas Road from a point 434 feet south of the centerline of Via Andorra to a point 565 feet south of the centerline of Via Andorra.
- On the west side of Cieneguitas Road from a point 690 feet south of the centerline of Via Andorra to a point 713 feet south of the centerline of Via Andorra.
- On both sides of State Street from the centerline of State Route 154 to the Santa Barbara City limits.
- On the west side of Vieja Drive from the centerline of Sandpiper Lane to a point 70 feet north of the centerline of Sandpiper Lane.
- On the south side of Segovia Road from its easterly terminus to a point 30 feet west of its easterly terminus.
- On the north side of Black Oak Drive from the centerline of Stillwell Road to a point 176' west of the centerline of Oak Bluffs Drive (west), effective upon acceptance of Black Oak Drive into the County maintained road system.
- On the south side of Black Oak Drive from the centerline of Stillwell Road to a point 172' east of the centerline of Aquinnah Lane, effective upon acceptance of Black Oak Drive into the County maintained road system.

Establishing Various No Parking Restrictions on Various Roads in the First, Second, Third & Fourth Supervisorial District

15 Minute Time Limit Parking Zone (9:00 am to 6:00 pm excluding Sundays and Holidays)

• On the north side of Trigo Road from a point 376 feet west of the centerline of Embarcadero Del Mar to a point 419 feet west of the centerline of Embarcadero Del Mar.

1 Hour Time Limit Parking Zone (9:00 am to 5:00 pm Monday through Friday except holidays)

• On the north side of Trigo Road from a point 256 feet west of the centerline of Embarcadero Del Mar to a point 376 feet west of the centerline of Embarcadero Del Mar.

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to designate said locations with appropriate markings and/or signs as time and resources permit.
