2006-11 ANNUAL ACTION PLAN AMENDMENTS Santa Barbara County HOME Consortium & CDBG Urban County Partnership August 2011

I. Introduction

The purpose of this amendment is to update the funding allocations proposed in the Santa Barbara County HOME Consortium and CDBG Urban County Partnership 2011 Annual Action Plan (Action Plan), and reprogram funds from the 2006, 2007, 2008, 2009 and 2010 Action Plans that were reserved for projects that did not move forward. The County of Santa Barbara is the lead agency of the Urban County Partnership which also includes the cities of Buellton, Carpinteria, Lompoc and Solvang, and is also the lead agency of the HOME Consortium which includes the members of the Urban County as well as the cities of Goleta and Santa Maria. To receive a final reservation of funds, all projects must undergo an application process, staff review, evaluations by review committees, and approval by city councils and the County Board of Supervisors. The 2006-2011 amendments, including the deobligation and reprogramming of prior year reservations, are subject to approval by the County Board of Supervisors.

The United States Department of Housing and Urban Development (HUD) awards federal grant funding annually to the Santa Barbara County HOME Consortium and Urban County Partnership through three programs administered by HUD. The HOME Investment Partnerships (HOME) program provides limited subsidies designed to leverage public and private funds necessary to enable the financial feasibility of affordable housing projects. The Community Development Block Grant (CDBG) program provides funding to develop viable communities and assist low and moderate income persons. The Emergency Shelter Grants (ESG) program provides homeless persons with basic shelter and essential services.

In May of 2011, HUD published its 2011 allocations for the HOME, CDBG and ESG programs. This included an 11.7% reduction to the HOME program, and a 16.5% reduction to the CDBG program. The ESG program allocation has increased for 2011 and is being issued in two phases; the first phase includes a slight reduction from the estimated allocation, and the second phase will provide additional funding, though the second phase will be implemented later in the program year with the finalization of the Homeless Emergency and Rapid Transition to Housing (HEARTH) Act regulations. The following table provides the estimated amounts identified in the Action Plan that was published prior to HUD issuing the 2011 allocations, along with the actual amounts of HOME, CDBG and ESG that were allocated to the Santa Barbara County HOME Consortium and CDBG Urban County Partnership in 2011:

V. Santa Barbara County HOME Consortium & CDBG Urban County Reprogrammed Funds

HUD imposes strict expenditure requirements under its HOME and CDBG Program regulations. The ability to acquire sufficient funding necessary for development, and the identification of ready projects are necessary to avoid deobligation under HOME and CDBG Program expenditure requirements. Therefore, the County may be required to shift funding commitments from one year to another and/or from one project to another to ensure timely expenditure of funds. Tables A-13 and A-14 summarize the HOME and CDBG funds to be reprogrammed from prior years into the 2011 Action Plan, subject to approval by the County Board of Supervisors:

Casa del Desarrollo

The County has deobligated \$387,290 of HOME funds reserved for the Casa del Desarrollo project through the 2006, 2007, 2008 and 2009 Action Plans, and has reprogrammed \$292,191 of these funds through its 2011 NOFA. The balance of deobligated funds will be provided to Rancho Hermosa, as discussed below.

Rancho Hermosa

The Rancho Hermosa project was included in the 2008 Action Plan approved by the Board on May 13, 2008, and received reservations of both HOME and CDBG funds. The County has replaced the \$95,099 of CDBG funds reserved for the project with an equal amount of HOME funds, and reprogrammed the CDBG monies through its 2011 NOFA. This exchange of funds will result in more efficient contract preparation and monitoring, as all project funds provided by the County will be included under one contract and will be required to comply with only one set of regulatory requirements. As a result of this exchange, \$95,099 of County HOME funds has been deducted from the total amount available to County projects in the 2011 Action Plan. The total amount of County HOME funds reprogrammed in the 2011 program year is \$387,290 as reflected in Table A-13, while the total amount of reprogrammed HOME funds available to projects in the 2011 Action Plan is \$292,191.

^{\$292,191} of this amount is being reprogrammed to 2011 Action Plan projects. The balance of \$95,099 is being reprogrammed to Rancho Hermosa, which was included in the 2008 Action Plan approved by the Board.

Rancho Hermosa

As stated, the County has replaced \$95,099 of CDBG funds dedicated to the Rancho Hermosa project in the 2008 Action Plan with HOME funds. As a result, \$95,099 of County CDBG Capital Project funds have been reprogrammed and added to the total amount available to County projects in the 2011 Action Plan.

Bridgehouse Greenhouses

The County will deobligate \$44,221 of CDBG funds reserved for the Bridgehouse Greenhouses through the 2009 Action Plan and reprogram these funds into the 2011 Action Plan, subject to approval by the County Board of Supervisors.

Bridgehouse Shelter

The County will deobligate \$15,000 of CDBG funds reserved for the Bridgehouse Shelter through the 2010 Action Plan and reprogram these funds into the 2011 Action Plan, subject to approval by the County Board of Supervisors. As no more than 15% of a jurisdiction's annual CDBG allocation may be used for public services, these funds will been added to the total amount available to County CDBG Capital Projects in the 2011 Action Plan.

Mark's House

The County will deobligate \$5,000 of CDBG funds reserved for the Mark's House Transitional Shelter through the 2010 Action Plan and reprogram these funds into the 2011 Action Plan, subject to approval by the County Board of Supervisors. As no more than 15% of a jurisdiction's annual CDBG allocation may be used for public services, these funds have been added to the total amount available to County CDBG Capital Projects in the 2011 Action Plan.

Table A-14 – Of the \$50,000 of CDBG deobligated from the North County Rape Crisis Center, only \$15,845 is being reprogrammed into the 2011 Action Plan. The remaining balance of \$34,155 will be utilized for other future eligible CDBG Capital Projects.

North County Rape Crisis Center

The County will deobligate \$50,000 of CDBG funds reserved for the North County Rape Crisis Center through the 2008 Action Plan and reprogram \$15,845 of these funds into the 2011 Action Plan, subject to approval by the County Board of Supervisors. The remaining balance of \$34,155 will be utilized for other future eligible CDBG Capital Projects.

Housing Rehab Loan Program

The City of Lompoc has deobligated \$53,955 of CDBG funds reserved for its Housing Rehab Loan Program through the 2010 Action Plan and has reprogrammed these funds into its 2011 NOFA. The aggregate amounts of CDBG Capital Project funds available to City of Lompoc projects in the 2011 Action Plan total \$349,765, and include its 2011 CDBG Capital Project allocation of \$295,810 and the \$53,955 of reprogrammed CDBG monies.
