Accept permanent Easement Deeds from the Crystal Creek Homeowner's Association, Robert and Barbara Diyorio, and the Margaret Heath and Joel Heath trusts, authorizing the Clerk of the Board to sign the Certificates of Acceptance attached to the Permanent Easement deeds regarding the above referenced sewer main.

Summary Text:

Acceptance of these easement deeds will provide for their recordation and the transfer of control and possession of the existing sewer main to the Laguna County Sanitation District. The easements will provide for proper ownership of the sewer improvements built by the developer to serve the housing tract.

Background:

The Crystal Creek housing development was created by TM No. 13,930 recorded in 1989. Public improvement plans for the development included sewer mains primarily located in roads dedicated as public rights of way. However, certain sewer improvements extend outside the public road rights of way through a common open space lot APN 105-310-040), the corner of a developed lot (APN 105-310Subject: Deed Acceptance for the Crystal Creek Housing Development

015), and offsite onto an adjacent parcel (APN 105-060-033). The attached documentation provides for public sewer easements to be held by the Laguna County Sanitation District as intended when the development was created.
