Summary Text:

Pursuant to Section 9314 of the Public Resources Code, we recommend that the Board of Supervisors appoint the four qualified candidates listed above as Directors for the Cachuma Resource Conservation District.

Background:

In 1986, Section 9314 of the Public Resources Code was amended to allow Resource Conservation Districts to request by resolution, that the Board of Supervisors appoints directors to the governing board of their district.

At the June 26, 2007 meeting, the County Board of Supervisors approved a resolution from the Cachuma Resource Conservation District requesting that the Board appoint the district's directors as provided for in Public Resources Code Section 9314. Pursuant to Section 9314, the resolution shall remain in effect until rescinded by the board of directors of the Cachuma Resource Conservation District, or until a petition requesting the rescission is received by the elections official.
