Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1, An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

On Thursday, April 27th, 2006 two (2) bids were opened for the Construction of 2005/2006 Measure 'D' Roadway Repair and Preventive Maintenance Application of Asphalt Concrete Overlay in the 3rd, 4th and 5th Supervisorial Districts in Santa Barbara County, Project Number 810523. The lowest responsible bid was submitted by Granite Construction Co. in the amount of \$1,382,493.00, which was 5.6% below the Engineer's Estimate. Staff has performed an analysis of the bids received and has determined that the low bid is responsible and reasonable. Staff recommends awarding this contract to Granite Construction Co.

The project utilizes one of the strategies that the Department employs in its annual Pavement Preservation Program and consists of the placement of a Type B asphalt concrete overlay over an asphalt concrete leveling course and pavement reinforcing fabric at various locations throughout Santa Barbara County. Approximately 8.8 lane miles of County maintained roadway will be resurfaced with construction of this project.



Your Board approved the project as part of the 2005/2006 Capital Improvement Plan. The specific project locations are approved by your Board in the FY 2005/2006 Road Maintenance Annual Plans (RdMap) and are attached for your information.

This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder.
