**Recommended Actions:**

That the Board of Supervisors:

- A) Approve, ratify and authorize the Chair of the Board of Supervisors to execute an agreement with the California Department of Pesticide Regulation (DPR) for the Agricultural Commissioner's Office (CAC) to be reimbursed for contracted activities pertaining to the collection of samples of fumigation tarpaulins for submission to the DPR laboratory for the period of June 1, 2019 through April 1, 2021 in the amount of \$12,500.
- B) Determine that the above action involves government funding mechanisms and/or fiscal activities and is not a project under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines section 15378(b)(4).

**Summary Text:**

This item is on the agenda for the Board of Supervisors to approve and authorize an agreement with the DPR to receive reimbursement for the cost of all activities associated with the collection of tarpaulin samples from DPR's Chloropicrin tarpaulin list used during field fumigant applications, obtain a copy of the Fumigant Management Plan and the Post Application Summary and submit the samples and information to the DPR laboratory for analysis.

**Background:**

Over the past several years DPR has worked with CACs, the U.S. Environmental Protection Agency (US EPA), pesticide registrants, and tarpaulin manufacturers to help protect human health. The results of this effort are the phase II soil fumigant labels, regulations, and suggested permit conditions. To ensure the protection of human health these newly implemented measures need to be evaluated to determine if they are being used correctly and if they are working.
