Title: Establish Appropriations for Dept 990 Funding Transfer to City of SM for Sports Complex  
Budget Action: Establish appropriations of \$1,500,000 in General County Programs General Fund for services and supplies funded by release of Committed Emerging Issues fund balance.

Justification: This budget revision establishes appropriations of \$1,500,000 to be transferred to the City of Santa Maria from the General County Programs General Fund for the Santa Maria Sports Complex. These funds were approved and preserved in the General County Programs Committed Emerging Issues fund balance as part of the FY 2021-22 Adopted Budget. This sports complex will be located in Santa Maria on Depot Street, and includes project plans for soccer fields, basketball courts, a walking trail, exercise stations, a playground, and restroom facilities. Other funding sources secured for the project include \$6,200,000 from the California Department of Parks and Recreation, \$1,000,000 from the City of Santa Maria, and \$1,000,000 from the FY 2023-24 State Budget.
