SUBJECT:	Declaration of Support for The National Housing Trust Fund Campaign

Recommendation(s):

That the Board of Supervisors:

- A) Approve the submission of the attached Declaration of Support (Attachment A) endorsing the establishment of the National Housing Trust Fund Campaign and;
- B) Authorize the Chair of the Board to sign the attached letters (Attachment B) to the County's members of Congress urging them to support the Trust Fund.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goals No. 7, Strengthen the Safety and Well-Being of Children and Their Families to Ensure a Strong Future for our Community, and Goal No. 5, Maintain and Enhance the Quality of Life for all Residents.

Executive Summary and Discussion:

On April 29, 1993, your Board approved the "Program Uses, Funding Criteria and Guidelines of the Housing Trust Funds" for the Department of Housing and Community Development (HCD), establishing a basis for use of other federal or state funding resources. HCD has identified the establishment of a National Housing Trust Fund as a means to double the County's resources through its Special Revenue Fund (Housing Trust Fund).

A House Bill for the establishment of a National Housing Trust Fund has been introduced to the current Congress. The House Bill, H.R. 1102, co-sponsored by Congresswoman Capps, would use profits generated by Federal housing programs to fund additional affordable homeownership and rental housing opportunities.

Both Bills propose to subsidize the Trust Fund from revenues generated from two sources: They are as follows:

- 1) any revenue generated by the Mutual Mortgage Insurance in excess of the amount necessary for the Mutual Mortgage Insurance Fund to maintain a determined capital ratio; and
- 2) revenue generated by the Government National Mortgage Association in excess of their administrative costs.

It is proposed the Secretary of Housing and Urban Development would be responsible for the expenditures of the funds.

There are plans to introduce a similar bill in the Senate. A National Affordable Housing Trust Fund bill was introduced in the Senate in 2001 but it did not pass. Both Senators Feinstein and Boxer were co-sponsors of the 2001 bill.

HCD is always searching for additional funding sources to help supplement the Department's existing funding sources. Creation of a National Housing Trust Fund would allow the County to access additional funding in the form of cash match to further stretch the County funds available to finance affordable housing. The National Housing Trust Fund could potentially provide 100% cash match to the County's Housing Trust Fund.

Mandates and Service Levels: The Housing Finance Program is not mandated; however, acceptance of funds to carry out affordable housing activities requires the County to comply with the conditions attached to those funds.

Fiscal and Facilities Impacts:

Support of the National Housing Trust Fund may add another source of housing funds for Housing and Community Development. There would be no County funds required to either match or add to the Trust Fund. There are no facilities impact.
