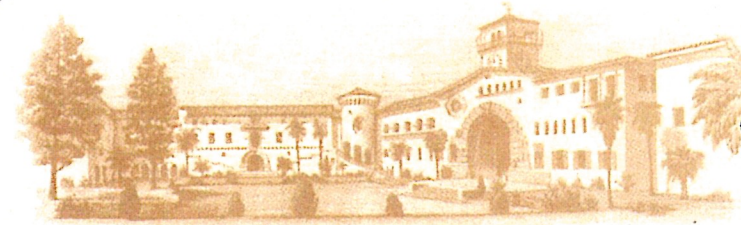

WHEREAS, Timothy Morgan retired from County service on Sunday, March 22, 2020, having faithfully served the Sheriff's Office for over 25 years, during which he served as a Custody Deputy, Senior Custody Deputy and Custody Sergeant.

WHEREAS, Timothy Morgan started his career with Santa Barbara County on February 27, 1995, as a Corrections Officer in the Main Jail. In 1996, he became a member of the Special Operations Response Team (SORT). On November 2nd, 1998 he became a Senior Custody Deputy and was assigned to the Main Jail. On September 6th, 1999 he was appointed as a Custody Sergeant and remained assigned to Custody Operations. During his twenty-five years of service, he has worked in various assignments such as; Main Jail, SORT, Santa Maria Branch Jail, RAU, Transportation and Training Bureau. On September 19, 2013 he was awarded Sheriff's Office Meritorious Service Award.

WHEREAS, Timothy Morgan, throughout his career, provided the employees of the Sheriff's Office positive leadership and professionalism, allowing him to rise steadily through the organization, attaining the rank of Sergeant; and

WHEREAS, Timothy Morgan provided the citizens of Santa Barbara County extraordinary professionalism and sensitive correction service while dedicating his life to Law Enforcement Profession; and

WHEREAS, Timothy Morgan's knowledge, skills and experience contributed greatly to the overall professionalism and the goals of the Santa Barbara County Sheriff's Office as well as the objectives of the County.
