## PUBLIC NOTICE

### County of Santa Barbara Community Development Block Grant (CDBG) Urban County Partnership FY 2019-20 Substantial Amendment

The County of Santa Barbara Department of Community Services (CSD), Division of Housing and Community Development (HCD) invites public comments on a Substantial Amendment to the CDBG Urban County Partnership's FY 2019-20 Annual Action Plan. The County is the lead entity of the Urban County Partnership, which includes the County, and the cities of Buellton, Carpinteria, and Solvang. CDBG programs provide communities with resources to support a variety of programs to assist low- and moderate-income persons.

#### **Draft Substantial Amendments to the FY 2019-20 Action Plan**

The draft FY 2019-20 Annual Action Plan Substantial Amendment includes funding recommendations for specific programs and projects. The funding recommendations will be considered by the County Board of Supervisors (Board) at a public hearing on the date noted below during which the Board will make final funding decisions. The final Substantial Amendment to the FY 2019-20 Action Plan will be submitted to the U.S. Department of Housing and Urban Development (HUD).

The draft FY 2019-20 Annual Action Plan Substantial Amendment includes a total of \$621,616 in CDBG funds to be used for five (5) capital projects. The projects and amounts include: 1) \$450,000 to Good Samaritan Shelter for acquisition and property improvement costs for a three-bedroom single-family residence to be used as transitional housing for women; 2) \$58,485 in additional funding to Cuyama Valley Recreation District to purchase and install a Modular Concession Stand and Restroom Facility in New Cuyama; 3) \$57,750 to Good Samaritan Shelter for replacement of flooring in an emergency shelter for homeless persons in Santa Maria; 4) \$30,274 to Habitat for Humanity of Southern Santa Barbara County for a Low-Income Homeowner Repair Program in south Santa Barbara County; and 5) \$25,107 in funding to Women Economic Ventures to partially fund their countywide microenterprise self-employment training program.

The draft FY 2019-20 Substantial Action Plan Amendment will be made available for a 30-day public review and comment period from **Friday, April 3, 2020 through the end of the public hearing on this item on Tuesday, May 5, 2020**. The draft document will be available for review at the CSD office at 123 E. Anapamu St, Suite 202 in Santa Barbara and the Betteravia Government Center at 511 E. Lakeside Parkway Suite 141 in Santa Maria. Copies will also be available for review on the HCD website: <http://www.countyofsb.org/housing>
