My name is Violet Sophia Grace Hauenstein. I live in Lompoc Valley.

I am here today because **of a** conflict YOU have allowed to develop in our schools here in Santa Barbara County.

Right now, I am anxious and afraid to perform my Physical Education class at Vandenberg Middle School.

There is a problem with allowing boys, to be specific **humans** with XY chromosomes, into the girls locker rooms at our school.

While I was changing my clothes, I was noticed by 3 students, one of them is a boy who "identifies" as female. He is not female. He does not have XX chromosomes.

It is a fact that boys, having XY chromosomes, often behave more aggressively than females.

This boy body-shamed me and started a conflict with me in the locker room. This embarrassed me publicly and personally.

My other females peers witnessed this and they were visibly uncomfortable and so was I.

Now, I feel like girls are being watched and humiliated by a boy when we are undressed.

This is a violation of my personal and civil rights.

We are NOT in a public space. We are changing our clothes.

Why is this being allowed at all? It hurts me and other female peers.

I want to know what this Board of Supervisors is going to do about the fact I am now anxious and afraid.

I am not trying to be political or rude to him but this really needs to go back to the way it used to be.

I feel like I am not being protected by my Civil Rights. I feel like there are no rules.
