Title: Transfer appropriation and recognize revenue for purchase of COBAN equipment.

Budget Action: Transfer appropriations of \$601,000 in Sheriff General Fund appropriations from Salaries and Benefits to Capital Assets for purchase of COBAN in-car video equipment

and increase appropriations of \$24,000 in Sheriff General Fund for Capital Assets funded by unanticipated revenue from the sale of surplus property.

Justification: This revision will shift unused salary and benefit dollars to the capital asset object level to fund the purchase of the COBAN units and in-car modems. The funding is

partially due to vacancies in the department from throughout the year and concessions from the Deputy Sheriff's Association and Sheriff's Managers Association. In

addition, \$24,000 from the return of old equipment will be recognized as revenue and will cover a portion of the cost.
