Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1, An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

On Thursday, January 31, 2002, six (6) bids were opened for the 2001/2002 Measure 'D' Concrete Repair, Tree Removal, Tree Root Pruning and Shielding in the Second and Third Supervisorial Districts of Santa Barbara County, County Project No. 820472. The lowest responsible bid was submitted by Granite Construction Company, in the amount of \$580,085.00, which was 4% below the Engineer's Estimate. Staff has performed an analysis of the bids received and has determined that the low bid is responsible and reasonable. Staff recommends awarding this contract to Granite Construction Company, a California Corporation.



The project is one of the strategies the Department employs in its annual Preventive Maintenance Program and consists of repair of the existing hardscape by the removal and replacement of damaged concrete curbs, gutters and sidewalks, installation of federally mandated curb ramps, tree removal, tree root pruning and shielding. Approximately 5,278 linear feet of sidewalk and 4,237 linear feet of curb and gutter will be repaired with the construction of this project.
