RECOMMENDATION

That the Board of Supervisors adopt a resolution establishing a one directional stop control at the intersection of Dickinson Street (eastbound) and Harmony Lane in the Orcutt area.

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure and Goal

EXECUTIVE SUMMARY AND DISCUSSION

The intersection of Dickinson Street (eastbound) and Harmony Lane is located in the eastern part of Orcutt. These roadways are both residential roads. The intersection is currently without stop controls in all directions. Vehicles approaching this three-way intersection from Dickinson Street (eastbound) and exiting onto Harmony Lane have restricted sight distance looking north due to the contour of the roadway and foliage growing along side the roadway. Based upon our investigation and the sight distance restrictions at this intersection, it was determined that a one-directional stop control, be established on Dickinson Street (eastbound). The Public Works Traffic Section has prepared the attached resolution to establish a one-directional stop control at the following intersection.

- On Dickinson Street (eastbound) at its intersection with Harmony Lane.
