SUBJECT: PC 1000 and DUI Programs Service Contracts for FY 06/07

Recommendation(s):

That the Board of Supervisors:

Approve and execute agreements for the provision of PC 1000 Drug Diversion Program and DUI Program services, for the period of July 1, 2006 through June 30, 2007, to permit recovery of the County portion of fees for services rendered to clients by the following agencies:

- A.) Central Coast Headway for PC 1000 and DUI Program services
- B.) Council on Alcoholism and Drug Abuse for PC 1000 and DUI Program services
- C.) Charles Golodner for PC 1000 Program services
- D.) Zona Seca, Inc. for PC 1000 and DUI Program services

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work and Visit.

Executive Summary and Discussion:

PC 1000, Drug Diversion Program began in Santa Barbara County in 1995. Penal Code Section 1000 (PC 1000) provides Drug Diversion Program services for clients who are formally charged with first-time alcohol/ drug misdemeanor offenses and who are found eligible for deferred entry of judgment at the discretion of the local courts. Those who are found to be suitable for treatment and rehabilitation are provided education and counseling services through 6-month, 9-month, 12-month and 18-month programs operated by community based organizations. Upon successful completion of the program, the charges are dismissed.

Driving Under the Influence (DUI) programs assist any California resident in restoring their driving privileges following a conviction for driving under the influence. Clients are required to enroll and complete a state-licensed DUI program when referred by the courts. Programs offered vary in level and are commensurate to the level of offense. Services offered include individual and group counseling, psycho-education of substance abuse, self help, and relapse prevention strategies.

Providers of PC 1000 and DUI programs collect program fees from clients, as approved by the County and State Alcohol and Drug Program,. Pursuant to Penal Code Section 1211, County Alcohol and Drug Program is authorized to assess an administrative charge to help offset costs in administering these programs.

It is anticipated that 400 clients will be enrolled in the Drug Diversion Programs County-wide in FY 06/07. The services to be provided by each agency are:

PC 1000 DRUG DIVERSION - SOUTH COUNTY:

Zona Seca
Council on Alcoholism and Drug Abuse

PC 1000 DRUG DIVERSION - NORTH COUNTY:

Central Coast Headway - Santa Maria and Lompoc
Charles Golodner Counseling Group

Mandates and Service Levels:

No change in programs or service level.

Fiscal and Facilities Impacts:

The recommended action will not require any General Fund Contribution or have any impact on the General Fund. The proposed revenue is included in the FY 2006-07 Recommended Budget, ADP – Treatment Services Budget Unit 5260, Account 5379. Program services are funded entirely from client fees. The Alcohol and Drug Program operates under a capped budget supported by an annual subvention of state and federal funds, as well as local funds obtained from fines on drinking driver convictions. The anticipated revenue from these administrative charges in FY 06/07 for the combined programs is \$75,345. There is no facilities impact.
