Budget Action: Increase appropriations of \$90,300 in General County Programs General Fund for Intrafund Expenditure Transfers (+) funded by release of Restricted (line item 9768)

Fund Balance. Increase appropriations of \$90,300 in the District Attorney's Office General Fund for Salaries and Benefits (\$90,300) funded by an Intrafund transfer from

the General Fund.

Justification: The County of Santa Barbara's FY 2023-24 Adopted Budget included a criminal justice set-aside of Proposition 172 funds held in General County Programs for future

allocation, including ongoing funding for 1.0 FTE Deputy District Attorney (DDA) in the District Attorney's Office (DA). The set-aside provision indicated that competing

criminal justice needs would need to be clarified in the subsequent months, and that if higher priorities were not identified, the CEO's Office would bring a

recommendation to the Board to release the funding to the departments.

At this time, the CEO's Office recommends the release of the set-aside funds for the DA's Parole Hearing DDA position. The funding amount in this budget revision reflects the anticipated costs in the current fiscal year (FY 23-24). The full set-aside amount of \$156,600 will be built into the DA's ongoing allocation of Proposition 172

funding.
