I am a senior citizen on a fixed income. I live on \$1517 per month, a sum that never increases. Despite this, my expenses increase regularly (astronomically in the past year). At the moment, my rent and sewer costs are \$973.90 per month. I have seen no added value since the day I moved in to this park in 2016, yet the costs still rise. I know I am not the only person in this community having this experience. I simply cannot afford another increase, especially considering that our rate was raised just last year.
