Whereas on May 3, 2024, the Board of Supervisors of the County of Santa Barbara approved amendments to the County's Local Coastal Program by amending the CZO, Article II of Chapter 35, Zoning, of the County Code, regarding 2023-2031 Housing Element Update Rezone Amendments (Ordinance No. 5209, Case No. 24ORD-00008);
- E. Whereas on May 3, 2024, the Board of Supervisors of the County of Santa Barbara approved amendments to the County's Local Coastal Program by amending the CZO, Article II of Chapter 35, Zoning, of the County Code, regarding 2023-2031 Housing Element Update Rezone Amendments (Ordinance No. 5208, Case No. 24RZN-00002);
- F. Whereas on May 3, 2024, the Board of Supervisors of the County of Santa Barbara approved amendments to the County's Local Coastal Program by amending the Coastal Land Use Plan, regarding the 2023-2031 Housing Element Rezone Amendments (Resolution No. 24-93, Case No. 24GPA-00004);
