- B. Conduct a second hearing on **April 13, 2004** and adopt the attached ordinance, amending Section 23-11.1 of the Santa Barbara County Code.

At this time there are no existing ordinances allowing green curb markings in the Santa Barbara County Code. This action will allow future green zones to be designated as needed which will allow the Department to be more responsive to the needs of the communities we serve.
