

SEVENTH AMENDMENT TO AGREEMENT

between

COUNTY OF SANTA BARBARA

and

CITY OF SANTA BARBARA

for

ANIMAL SHELTER SERVICES

Effective January 1, 2021

THIS IS THE SEVENTH AMENDMENT TO THE AGREEMENT (hereafter Seventh Amendment) for Animal Shelter Services (hereafter Agreement), made by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter COUNTY), and the City of Santa Barbara, a charter city within Santa Barbara County (hereafter CITY).

WHEREAS, the parties desire to amend the Agreement to extend the term of the Agreement and to adjust the compensation payable to COUNTY for services performed under the Agreement; and

WHEREAS, this Seventh Amendment incorporates the terms and conditions set forth in the Agreement, entered into on July 1, 2011, First Amendment, Second Amendment, Third Amendment and Fourth Amendment, and Fifth Amendment, Sixth Amendment, except as may be modified by this Seventh Amendment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CITY hereby agree to amend the Agreement as follows:

1. **Definitions.** Capitalized terms used in this Seventh Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

The Agreement is amended as follows:

This Agreement is amended as follows:

4. **TERM.** The term of this, Seventh Amendment shall be from January 1, 2021 through June 30, 2021.

5. **COMPENSATION OF COUNTY.** For services rendered from the COUNTY-operated shelter in Goleta between January 1, 2021 and June 30, 2021, CITY shall pay COUNTY \$204,880, billed in two equal payments of: \$102,440. Payments to COUNTY shall be made within thirty (30) days of receipt of invoice. Invoices shall be delivered to the CITY address specified in Section 3, NOTICES of Agreement.

3. **Counterparts.** This Seventh Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
