Whereas, Bob has held positions at Los Prietos Boys Camp, as an investigation and supervision Deputy Probation Officer in both the Adult and Juvenile Divisions of the Santa Barbara County Probation Department and served as both Adult and Juvenile Superior Court Hearing Officer; and

Whereas, Bob was promoted to Senior Deputy Probation Officer in May 1990 and to Supervising Probation Officer in June of 1999, has worked in both the Santa Barbara and the Lompoc offices and has always been appreciated as a supportive supervisor who is approachable, a mentor of new staff, a gentleman and a genuinely nice guy; and

Whereas, Bob participated in the acquisition of the grant and served as Project Director for the Partnership For Families Juvenile Crime Prevention Grant in Lompoc in 1995, a five year, four million dollar project which involved the collaboration of fifteen separate community agencies; and

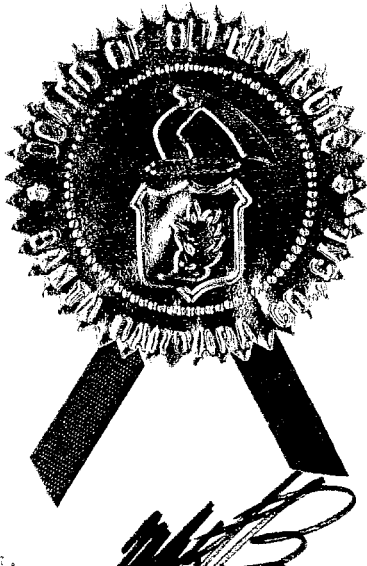
