Thank you for this information. Can you just confirm that if the Judsons withdraw their appeal, the permit, or permit approval, will include frosting requirement language identical to in the MPC's May 17, 2024, letter, i.e. to require "the windows on the west elevation of the detached garage shall be frosted for neighbor privacy" (or something very close to that). Following this confirmation, the Judsons will withdraw their appeal.
