WHEREAS, the United States Department of Homeland Security / FEMA, Homeland Security Grant Program provides financial assistance; and

WHEREAS, the Santa Barbara County Office of Emergency Management has coordinated a county-wide needs assessment to determine threat potential, vulnerability, and emergency responder capability; and

WHEREAS, the Santa Barbara County Office of Emergency Management coordinates grant funds to enhance emergency management agency capabilities, and the capabilities of first responders; and

WHEREAS, the Homeland Security Grant Program is administered through the California Governor’s Office of Emergency Services; and

WHEREAS, the grant program requires that jurisdictions applying for funding designate Authorized Officials who may apply for funding and execute applications and documents for the purpose of obtaining financial assistance;

NOW, THEREFORE, IT IS HEREBY RESOLVED Now, therefore, it is hereby resolved that the positions listed below are hereby designated as Authorized Officials and are authorized to submit and execute for and on behalf of the Santa Barbara Operational Area, a public entity established under the laws of the State of California, the grant application package and all necessary applications, contracts and agreements and amendments thereto for the completion of the grant application package for the purpose of obtaining federal financial assistance provided by the federal Department of Homeland Security and sub-granted through the State of California.
