Planning & Development is aware that the appellant has requested a continuance of the October 15, 2024, hearing. The Department does not support continuance of the item, for the following reasons:

- Planning & Development has a practice of giving each party, the applicant and the appellant, to reject one hearing date in order to ensure due process. In this case, the appellants rejected the offer of a hearing date of October 1, 2024. The appellant confirmed directly to staff in July of 2024 that they would be available for a hearing date of October 15, 2024 (see Attachment 1 and 2 emails).
- The project applicant is strongly opposed to a continuance (see Attachment 3, email from the applicant).
- County staff is fully prepared to present the project and appeal issues to the Board of Supervisors on the scheduled date of October 15, 2024.

There are no changes to staff's recommendation for denial of the appeal and approval of the project as reflected in the Board Letter for the project.
