Justification: This Board item recommends approval of an Agreement with Harris & Associates, Inc. (Harris) for delivery of a Strategic Plan for Workforce Housing Development and

Preservation (Plan). On September 22, 2023, HCD Staff reissued a Request for Proposals (RFP) to a wide range of qualified consultants to prepare a Strategic Plan for Workforce Housing Development and Preservation. Staff is recommending that the Board of Supervisors approve and authorize the Chair of the Board to execute the Agreement with Harris in the amount of \$216,825. Harris will deliver a Plan to inform, guide and influence future land use, housing projects and programs that can be implemented to improve the County's response to the lack of housing in primarily unincorporated areas of the County for the County's workforce. These efforts will be

funded with ARPA monies.
