**NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT,  
PUBLIC WORKSHOP AND PUBLIC HEARING**

**DRAFT RESOLUTION  
APPROVING  
POST-CONSTRUCTION STORMWATER MANAGEMENT REQUIREMENTS  
FOR DEVELOPMENT PROJECTS IN THE CENTRAL COAST REGION**

Section 402(p) of the Clean Water Act (CWA) requires National Pollutant Discharge Elimination System (NPDES) permits for stormwater discharges from municipal separate storm sewer systems (MS4s). MS4s in the Central Coast are enrolled under the State-wide NPDES General Permit for the Discharge of Storm Water from Small Municipal Separate Storm Sewer Systems, Order No. 2003-0005-DWQ (Phase II Municipal General Permit).

Per the Phase II Municipal General Permit, the MS4s in the California Regional Water Quality Control Board, Central Coast Region (Central Coast Water Board) participating in the Central Coast Joint Effort for Hydromodification Control and LID are required to develop and implement long-term hydromodification control criteria to control stormwater runoff from new development and redevelopment. The Draft Resolution refers to the criteria developed through the Joint Effort as Post-Construction Stormwater Management Requirements for Development Projects in the Central Coast Region (Post-Construction Requirements.)
