## **EXECUTIVE SUMMARY & DISCUSSION**

The California Vehicle Code requires that speed limits on roadways be established based on the findings of an Engineering and Traffic Survey. California law prohibits the use of radar speed enforcement along such roadways where the speed limit has not been set in accordance with the findings of this type of study within the last ten years.

In accordance with the California Vehicle Code, the Public Works Department has prepared Traffic and Engineering Surveys for Refugio Road in the Santa Ynez area and Bradley Road in the Orcutt area. These surveys were presented to the Traffic Engineering Committee on September 3, 2003 for their recommendation. Please refer to items 1 and 2 of the attached County of Santa Barbara Traffic Engineering Committee Summary of Proceedings.
