

ORDINANCE AMENDING SANTA BARBARA COUNTY CODE
CHAPTER 16 – FOOD AND FOOD PRODUCTS, ARTICLE II “MILK”

ORDINANCE NO. 14-_____

An ordinance of the County of Santa Barbara repealing Chapter 16, *Food and Food Products*, Article II, *Milk*, of the Santa Barbara County Code.

WHEREAS, periodically, an administrative clean-up of current Santa Barbara County Code is required to ensure that both County staff and the public have easy and logical access to current code regulations; and

WHEREAS, code has been discovered in Chapter 16, Article II, entitled “*Milk*”, §16-7 through 16-16 of the County Code which states that the Environmental Health Services (EHS) has jurisdiction for the regulation of dairy farms; and

WHEREAS, EHS has no such jurisdiction and therefore proposes that the outdated language and code chapter reference be repealed; and

WHEREAS, the Board of Supervisors finds that the amendments set forth in this ordinance are exempt from the California Environmental Quality Act (CEQA) review pursuant to 14 CCR §15061(b)(3); and

WHEREAS, the County of Santa Barbara has, in connection with proposed changes to Chapter 16, Article II, held a public hearing as part of a regularly scheduled meeting and published notice of the meeting, including a general description of the matter to be considered, in accordance with Government Code §6062a;

NOW THEREFORE, the Board of Supervisors of the County of Santa Barbara ordains as follows:

Chapter 16 – FOOD AND FOOD PRODUCTS, Article II, “*Milk*”

Article II entitled *Milk* of Chapter 16, sections 16-7 through 16-16, is hereby repealed on the effective date of this ordinance.

The repeal of said Article II of Chapter 16, sections 16-7 through 16-16, of the Santa Barbara County Code shall not have any effect on any criminal or civil litigation or claims, including claims for fees, arising under said Article and shall not operate as an abatement of any criminal or civil action or proceeding arising under said Article II, whether pending before or filed after the effective date of this ordinance.
