Recommended Actions:

Approve the budget revision to establish the budget appropriation for the Creekside Village Project.

Summary:

On April 12, 2011, the Board of Supervisors approved the final commitment of \$1,228,227 in Federal HOME Investment Partnerships Program funds and \$800,000 in Local Affordable Housing Funds for the Creekside Village Project. Creekside Village involves new construction of a low-income rental housing project on a vacant 5 acre parcel of land located at 33 St. Joseph Street in Los Alamos. The project will provide a total of 39 units in nine structures, for low and very-low income households, with a preference for agricultural worker households. Escrow for this project is expected to close on Wednesday, April 20, 2011 and the attached budget revision will establish a budget appropriation which will allow funds to be transferred to the project.

This budget revision brings the total cost for this project to \$2,028,227.

Creekside Village is new construction of a low-income rental housing project in a unincorporated area of northern Santa Barbara County in Los Alamos. The project will provide 39 units for low and very-low income households, with a preference for agricultural worker households. The Board of Supervisors on April 12, 2011, approved the final commitment of \$1,228,227 in HOME Investment Partnerships funding and \$800,000 of Local Affordable Housing Funds (Local Funds) for the aforementioned project and approved all loan documents.

Escrow for this project is scheduled to close on Wednesday, April 20, 2011.
