This letter of award is in response to the request for additional funds to support tuberculosis (TB) prevention and control activities submitted September 13, 2024 by the Santa Barbara County Public Health Department. The California Department of Public Health (CDPH) TB Control Branch (TBCB) has approved the request for additional food, shelter, incentives and enablers (FSIE) funds.

ADDITIONAL FSIE ALLOTMENT

The Santa Barbara County Public Health Department will receive up to \$22,350 from the CDPH TBCB to assist in providing food, shelter, incentives and enablers for TB patients, patients suspected of having TB and/or contacts to TB patients.

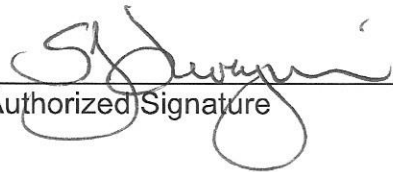
