

SCOPE OF WORK

2. This Agreement will commence on the start date January 31, 2017 as presented herein or upon approval by the State, whichever is later and no work shall begin before that time. This Agreement is of no effect unless approved by the State. Contractor shall not receive payment for work performed prior to approval of the Agreement and before receipt of notice to proceed by the Contract Manager. This Agreement shall expire on ~~December 31, 2019~~ **March 30, 2020.**
