Recommended Actions:

That the Board of Supervisors approve and execute a contract with Mental Health Systems, Inc. (a local vendor) in the amount of \$284,900 for the period of July 1, 2012 through June 30, 2013.

Summary Text:

The Alcohol, Drug and Mental Health Services (ADMHS) Department provides services to individuals with substance use issues through contracted providers. Approval of the recommended action will allow Mental Health Systems, Inc. to continue to provide alcohol and other drug (AOD) treatment and related services to residents of Santa Barbara County during FY 12-13.

Background:

Mental Health Systems, Inc. (Mental Health Systems) provides treatment services including outpatient individual and group counseling and drug testing in Santa Maria. Mental Health Systems also provides services to Substance Abuse Treatment Court (SATC) participants and offers peer supported self-help groups to clients who are waiting to enter treatment programs. Mental Health Systems will provide treatment services to approximately 128 clients in FY 12-13.

Performance Measure:

Specific outcome measures for the service contracts with the alcohol and drug treatment service providers were included as Exhibit E to the contracts. For example, the following are universal treatment services outcome measures:

- Clients receiving services for more than 30 days
- Clients that stay in treatment a minimum of 90 days
- Clients that successfully complete treatment
- Decreased readmission rates
