Title: Increase Appropriations in the Public Works Fund 1930

Budget Action: Increase appropriations in the Public Works Resource Recovery and Waste Management Fund 1930 for \$250,000 in Services and Supplies funded by the release of Retained Earnings.

Justification: Since the agreement with MSB Investors to operate the ReSource Center facilities was fully terminated on January 3, 2024, the County has assumed operations of the ADF and CMU until such time that an agreement with a separate operator can be implemented.

Part of the operation of the ADF and CMU facility includes the collection and management of rain water that has come in contact with digestate (CMU contact wastewater). Other liquids generated on site include landfill gas condensate and landfill leachate. To temporarily provide additional storage and manage excess wastewater that cannot be reused, the agreement with Pacific Petroleum provides for the rental of temporary tankage and the hauling of excess CMU contact wastewater to offsite facilities for proper disposal.
