Budget Action: Incr approp of \$2,837,356 in the PH Dept, HC Fund for S&B (\$873,822) and S&S (\$1,963,534) funded by an operating transfer from the Sheriff's Office and Probation

Dept's GF through the PATH 3 Justice Involved (JI) Funding award. Incr approp of \$2,384,492 in Sheriff GF for S&B (\$182,306) and Other Financing Uses (\$2,202,186) funded by release of Restr Sheriff Categorical Grants FB. Incr approp of \$635,170 in Prob GF for Other Financing Uses funded by release of Restr Local Realignment

Justification: Accepting the PATH 3 funding from the Sheriff's Office and Probation Department will increase the Health Department's budget by \$2,837,822. The Board is being asked

to approve the addition of 4.3 FTEs (and their related expenses) to provide the upfront cost of the PATH 3 Justice Involved Medical program. Future costs will be funded through MediCal. Release fund balance of \$2,384,492 in Sheriff's General Fund - Restricted Sheriff's Categorical Grants to fund a transfer to County Health (\$2,202,186)

and the addition of one Department Business Specialists II (\$182,306) for Cal-AIM.
