Accept the attached Notice of Completion and Acceptance for the Santa Barbara Cottage Hospital Regional Storm Drain System and authorize the Clerk to record.

Summary Text:

On July 18, 2006, the Board executed a Cooperative Agreement between the City and the Flood Control District that identifies ownership and maintenance responsibilities of the different components of the Santa Barbara Cottage Hospital (SBCH) regional storm drain system. The City will own and maintain the drop inlets, connector pipes, and laterals of the storm drain system. The District will own and operate the reinforced concrete box culvert that will drain into Mission Creek.

Pursuant to the Cooperative Agreement each agency is required to file a notice of completion and acceptance of the project to accept ownership and maintenance responsibilities identified in the Agreement.

Background:

SBCH, as part of its Seismic Retrofit and Master Plan Project was conditioned by the City to construct a regional storm drainage system along Junipero Street and Oak Park Lane in the City of Santa Barbara.

This system will collect a portion of the overflow from Mission Creek and return that overflow to Mission Creek.

The storm drain system will mitigate the affect to flows in the Mission creek over-bank areas caused by the project. The system will have a regional benefit and will improve drainage in the area.
