Budget Action: Establish appropriation of \$927,828 in Public Health Department (PHD) Health Care Fund for Capital Asset funded by a release of Restricted Fund Balance.

Justification:

This Budget Revision will release \$927,898 of funds from the Public Health Department (PHD) special revenue restricted fund balance to allow for the payment of 75% of the one-time Implementation Fee for the new Oregon Community Health Information Network (OCHIN) hosted Epic Systems, inc product Combined Practice

Management (PM)/Electronic Health Record (EHR) system (75% of \$1,237,197 is \$927,989). The additional 25% payment is due at system "go-live" - March 2018 - and is included in the PHD's Recommended FY 2017-18 budget submission. The funding for the system is from CenCal Health Access, Collaboration, and Expansion (ACE)

Medi-Cal incentive funds.
