Recommended Actions:

- a) Approve and authorize the Chair to execute agreements for crane services for the period of July 1, 2023 through June 30, 2025, in the amount of not to exceed \$1,000,000 with each of the following contractors:
 - i) T & T Trucking & Crane Service (a tri-county vendor)
 - ii) Big Red Crane Company, Inc. (a tri-county vendor)

- b) Approve and authorize the Chair to execute agreements for trucking services for the period of July 1, 2023 through June 30, 2025, in the amount of not to exceed \$2,000,000 with each of the following contractors:
 - i) Bob's Backhoe & Trucking (a local vendor)
 - ii) RLF Trucking & Grading Corp (a local vendor)
 - iii) Speed's Oil Tool Service, Inc. (a local vendor)

- c) Approve and authorize the Chair to execute agreements for street sweeping services for the period of July 1, 2023 through June 30, 2025, in the amount of not to exceed \$1,000,000 with each of the following contractors:
 - i) Surface Management Inc. DBA WaterWorks (a local vendor)
 - ii) SCA of CA, LLC (a tri-county vendor)
 - iii) Spadaro Enterprises, Inc. (not a local vendor)

- d) Find that the recommended actions to award contracts for crane, trucking, and street sweeping services are fiscal activities not constituting a “Project” within the meaning of the California Environmental Quality Act, as set forth in 14 CCR 15378(b)(4).

Summary Text:

This item is on the agenda in order to approve agreements for crane, trucking, and street sweeping services for the next two years. On April 10, 2023, the Flood Control District (District) sent out a Request for Proposals (RFPs) to 34 trucking, crane, and street sweeping companies and four plan rooms, mostly within the tri-county area. The RFPs were posted on PlanetBid and approximately 200 notifications were sent to account holders. The RFP was also published in the Santa Barbara Newspress and the Santa Maria Times on April 10 and 17, 2023.

On May 10, 2023, responsive bids were received from two crane, four trucking, and three street sweeping contractors. After reviewing the proposals, the above-identified contractors were selected based on cost, geographic location, and type of equipment available. Selecting contractors that are geographically diverse throughout the County and outside of the County saves money, time, and the ability for contractors to respond during flooding in the event that the north or south HWY 101 closes.

These agreements will provide crane, trucking, and street sweeping services needed to assist with the Flood Control’s routine maintenance program, emergency response efforts, prevention work, and other work needed for flood control purposes. All work will be provided at an hourly rate and on an as-needed basis.

After the initial emergency period, eligibility to apply for state and federal funding reimbursement requires contracts go through a competitive bidding process. In the past, this process has allowed the District to receive reimbursement for these costs from state and federal agencies for emergency response efforts.

Background:

In addition to reaching out to local companies for these services, an outreach was also conducted for Minority Business Enterprises and Women Business Enterprises (MBE/WBE) in the tri-county area. We conducted a targeted search on the Caltrans website and the Small Business Administration database for companies that provide crane, trucking, and street sweeping services located throughout the tri-county area. RFPs were emailed to all of the identified companies. Ads were also published online specifically seeking MBE/WBE in the Compliance News Publishing Company, DBE GoodFaith, and Construction Bid Source. MBE/WBE outreach is required during the procurement process for contracts to be eligible for federal funding after the exigent period of a disaster.

The awarding of these as-needed contracts does not itself constitute a “project” for purposes of the California Environmental Quality Act (CEQA), and environmental review of work performed under these contracts will be considered in connection with the future project for which the work is performed, as applicable.

Partial costs associated with these agreements are budgeted in every fiscal year in the Water Resources Division of the Public Works Department.

In general, these contracts have not historically approached the not-to-exceed limits of the contract. The limits are set at a high dollar amount in preparation for response to flood and fire events that may occur in any given year. If we do start to approach the contract limits, the District would, if needed, return to the Board to approve a Budget Revision Request to release designations and increase the contract amounts.
