Recommended Actions:

That the Board of Supervisors adopt eight Resolutions and approve Notice of Exemptions pursuant to the County's California Environmental Quality Act (CEQA) guidelines for the establishment of no parking zones, time limited parking zones and loading zones on:

- Northoaks Drive in the Vandenberg Village area; 3rd Supervisorial District
- Pardall Road in the Isla Vista area; 3rd Supervisorial District
- Embarcadero Del Mar in the Isla Vista area; 3rd Supervisorial District
- Embarcadero Del Norte in the Isla Vista area; 3rd Supervisorial District

Summary Text:

Several requests were received from citizens in the Vandenberg Village area to address safety concerns related to parking on Northoaks Drive. Recent roadway improvements have changed the existing conditions and the existing parking restrictions on various streets in the Isla Vista area.

Based upon our investigation, the Public Works Department has prepared the attached Resolutions (8) establishing new and revised parking restrictions at the following locations:

ADOPT

One-Hour Parking Zone

 On both sides of Pardall Road from a point 238 feet east of the centerline of Embarcadero Del Norte to a point 432 feet east of the centerline of Embarcadero Del Norte except for a 50 foot section from 238 feet east to 288 feet east of the Embarcadero Del Norte on the North side of Pardall Road.

ADOPT

One-Hour Parking Zone

• On the west side of Embarcadero Del Mar from a point 45 feet south of the centerline of Pardall Road to a point 218 feet south of the centerline of Pardall Road.

ADOPT

Commercial Loading Zone

• On the south side of Pardall Road from a point 176 feet east of the centerline of Embarcadero Del Mar to a point 222 feet east of the centerline of Embarcadero Del Mar.

ADOPT

No Parking Zone

• On the north side of Northoaks Drive from a point 30 feet east of the centerline of Constellation Road to a point 179 feet east of the centerline of Constellation Road.

ADOPT

15 Minute Parking Zone

- On the south side of Pardall Road from a point 227 feet east of the centerline of Embarcadero Del Mar to a point 326 feet east of the centerline of Embarcadero Del Mar.
- On the North side of Pardall Road from a point 238 feet east of the Embarcadero Del Norte centerline to a point 288 feet east of the Embarcadero Del Norte centerline.

RESCIND

15 Minute Parking Zone (Resolution #84-551)

- On the north side of Pardall Road from a point 150 feet west of the centerline of Embarcadero Del Mar to a point 215 feet west of the centerline of Embarcadero Del Mar.
- On the south side of Pardall Road from a point 176 feet east of the centerline of Embarcadero Del Mar to a point 222 feet east of the centerline of Embarcadero Del Mar.

• On the north side of Pardall Road from a point 114 feet east of the centerline of Embarcadero Del Norte to a point 226 feet east of the centerline of Embarcadero Del Norte.

RESCIND

No Parking Zone (Resolution #84-554)

- On the north side of Pardall Road from a point 215 feet west of the centerline of Embarcadero Del Mar to the centerline of Camino Pescadero.
- On the north side of Pardall Road from a point 226 feet east of the centerline of Embarcadero Del Norte to a point 313 east of the centerline of Embarcadero Del Norte.

RESCIND

No Parking Zone (Resolution #72-281)

• On the south side of Pardall Road from a point 67 feet east of the centerline of Camino Pescadero to a point 107 feet east of the centerline of Camino Pescadero.

Background:

Parking restrictions are either established or rescinded based on safety, necessity and how it relates to community usage as a whole. All of these factors are weighed by the Public Works Department and any changes recommended are presented to the Board of Supervisors for approval. These parking restrictions may include no parking, time limited parking, loading zones, vehicle height restricted parking, angle parking, handicapped parking or any combination of these restrictions. These Resolutions will result in a net increase of parking in the Isla Vista area.

Northoaks Drive:

The request for a no parking zone was initiated by the the citizens of Vandenberg Village concerned with the width and safety conditions of vehicles parking on the north side of this section of roadway.

Pardall Road:

The request for establishing a no parking zone, one hour parking zones, a loading zone and a 15 minute parking zone, was initiated by the roadway improvements being performed in the Isla Vista area as part of the Pardall Road Improvement project.

Embarcadero del Mar:

The request for a one hour parking zone was initiated by the roadway improvements being performed in the Isla Vista area as part of the Pardall Road Improvement project.

Pardall Road:

The request for rescinding certain portions of Resolutions (84-551, 84-554 and 72-281) is a result of the roadway improvements being performed in the Isla Vista area as part of the Pardall Road Improvement project.
