WHEREAS, OEM administers to the local oil spill contingency plan on behalf of the political subdivisions within the Santa Barbara County Operational Area; and,

WHEREAS, OEM and the California Department of Fish and Game, Office of Spill Prevention and Response are desirous of maintaining a local emergency management presence in the Area Contingency Plan (ACP) meetings, trainings, drills, and updates to the oil spill contingency plan; and,

WHEREAS, the California Department of Fish and Game, Office of Spill Prevention and Response has approved OEM to receive \$10,000 in oil spill contingency planning grant funds and now requires a resolution accepting these grant funds by the governing Board of the emergency management agency.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of Santa Barbara County, that the Emergency Operations Chief is hereby designated as the Authorized Agent for the County in relationship to the grant from the California Department of Fish and Game, Office of Spill Prevention and Response in the amount of \$10,000.00 for oil spill contingency planning for Santa Barbara County, a public entity established under the laws of the State of California.
