

**AMENDMENT
 TO

THIS AMENDMENT (hereinafter Amendment) is made by and between the County of Santa Barbara, a political subdivision of the State of California (hereinafter called **COUNTY**) and CalPortland Construction, with an address at 1625 East Donovan Road, Santa Maria, California 93454 (hereinafter referred to as **CONTRACTOR**) wherein COUNTY and CONTRACTOR agree to amend their November 3, 2015 Agreement (hereinafter Agreement) as specified herein.

WHEREAS, the Parties entered into an Agreement on November 3, 2015;

WHEREAS, COUNTY wishes to purchase 19,800 additional units of Type 3 Micro-surfacing material, for a total of 52,000 units;

WHEREAS, in light of the additional quantities requested, CONTRACTOR has agreed to supply all Type 3 Micro-surfacing material for \$4.79 per unit, \$0.71 less per unit;

WHEREAS, the Parties do not otherwise wish to disturb the terms of the Agreement.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree to amend the Agreement as follows:

1. Section 6. PAYMENT, paragraph 1 is amended to read:

6. PAYMENT As full compensation for furnishing all labor, supervision, overhead, materials and equipment and for doing all the work completed and embraced in this Agreement and subject to adjustments and liquidated damages, if any, as provided in the Contract Documents, the base amount to be paid to the CONTRACTOR for satisfactory completion of all requirements of the CONTRACTOR under this Agreement is and shall be \$552,433.00, to be paid as provided in the Contract Documents.
