That a public hearing on the said reports relating to adopting the proposed assessments within County Service Area 3, County Service Area 31 and the Santa Barbara North County Lighting District be, and it is hereby, set for the 9<sup>th</sup> day of June, 2026 at the hour of 9:00 a.m., or as soon thereafter as the order of business will permit, in the Board Hearing Rooms located at 105 East Anapamu Street in Santa Barbara and 511 East Lakeside Parkway in Santa Maria.

2. That the clerk be and is hereby authorized and directed to publish notice of the filing of said report and of said hearing on the report and for the filing of objections or protest thereto, in a newspaper of general circulation, circulated within the territory of the
