Recommended Actions:

That the Board of Supervisors consider the following:

- a) Approve, authorize and ratify the Chair to execute the First Amendment to Agreement for Service between the County of Santa Barbara and the City of Buellton to include the law enforcement menu item, Non-relief Traffic Deputy for Fiscal Year 2020/21 for services performed under the Agreement.
- b) Determine that the recommended action is not a "Project" within the meaning of California Environmental Quality Act, pursuant to CEQA Guideline Section 15378(b)(4), since the recommended action is a government fiscal activity which does not involve commitment to any specific project which may result in a potentially significant physical impact on the environment.

Summary Text:

This is an amendment to the original agreement for law enforcement services between the County of Santa Barbara and the City of Buellton. More specifically, this amendment includes the addition of a law enforcement menu item, the Non-relief Traffic Deputy, set forth in the Exhibit-A-1 of the original agreement.

Background:

The City of Buellton contracts law enforcement services through the County of Santa Barbara and already have a multi-year contract. For Fiscal Year 20/21 they added the menu item, Non-relief Traffic Deputy.

Fiscal and Facilities Impacts:

Budgeted: Yes

Fiscal Analysis: For FY 20-21 the projected Buellton Non-relief Traffic Deputy cost for the city is approximately \$303,000.00 (full cost including body + overhead). The total costs allowed to be charged under the Government Code are within 1.5% of the full cost to the County.
