Recommended Actions: Approve and execute the Agreement to Provide Information Services between the County of Santa Barbara and the Carpinteria-Summerland Fire Protection District which facilitates the provision of various Information Technology Services at County standard rates as published on the rate sheet each year.

Summary Text: The approval of this Agreement will allow General Service Information Technology Services (GS/ITS) to provide technical services and expertise to the Carpinteria-Summerland Fire Protection District (CSFD). Provision of these service and expertise will improve data communications between County Departments and the District including the ability to share public safety and financial information more effectively and securely.

Background: The Carpinteria-Summerland Fire Protection District currently utilizes the Internet to communicate with County resources. GS/ITS was enlisted by the County Sheriff Department to support the installation of a new CAD 911 system. This project called for improved communications between First Responder including Sheriff, Fire and Ambulance Services. During the course of this project analysis indicated that GS/ITS could facilitate robust, secure communications in support of this project in a cost effective manner. Additionally, the communications infrastructure created for this project could also be leveraged to facilitate secure communications with other County agencies as well.
