**Recommended Actions:**

That the Board of Supervisors approve and authorize the Agricultural Commissioner to execute an agreement with the California Department of Food and Agriculture to support the Light Brown Apple Moth program in the County of Santa Barbara for the period of July 1, 2008 through June 30, 2009 in the amount of \$28,478.38.

**Summary Text:**

This agreement will provide reimbursement for the cost of activities to perform regulatory work for the Light Brown Apple Moth which are primarily focused on implementation of Federal Domestic Quarantine Order DA-2007-42 and emergency response activities as a result of detections of light brown apple moth in regulated establishments.

**Background:**

In February of 2008, light brown apple moth was detected for the first time in Santa Barbara County. USDA and CFDA implemented quarantines in March of 2008, requiring additional regulatory activities to be performed by the Agricultural Commissioner's Office. The initial agreement for FY 07/08 was approved by the Board on 06/24/08 in the amount of \$9,968.56.
