Title: DA - Establish Appropriations for BJA Innovative Prosecution Solutions Grant

Budget Action: Establish appropriations of \$229,000 in District Attorney General Fund for Capital Assets (\$229,000) funded by unanticipated revenue from Intergovernmental Revenue-

Federal for the BJA Innovative Prosecution Solutions grant.

Justification: In FY 23-24, the District Attorney's Office was awarded the Innovative Prosecution Solutions Grant by the Department of Justice (DOJ) Bureau of Justice Assistance

(BJA). The grant provides state, local, and tribal prosecutors with direct funding, training, and technical assistance to develop effective strategies and programs to

address and prosecute individuals who commit violent crimes.

This grant will enable the District Attorney's Office to digitally transform the discovery process by utilizing a Digital Evidence Management System (DEMS). DEMS is a software platform that automates and streamlines the digital evidence ingestion, management, and distribution of evidence across the criminal justice system. The DEMS will provide District Attorney investigators and prosecutors with real-time access to digital information and will allow the District Attorney's Office to transfer discovery to the defense in a more complete, efficient, and expeditious manner.

The grant's project period is from October 1, 2023 through September 30, 2025, for a total award amount of \$385,000 over the two-year period. This budget revision request includes anticipated year-one revenue and expenses (FY 23-24). Future years' revenues and expenses will be included in the budget development process.
