SUMMARY OF THE QUALITY CARE INCENTIVE PROGRAM (QCIP) FOR SANTA BARBARA COUNTY (COUNTY)

CenCal Health is launching a re-designed and innovative pay for performance (P4P) program on March 1, 2022. The new program, known as the Quality Care Incentive Program (QCIP), will replace the PCP Incentive Program as well as all other existing incentive programs that are managed independently (including Diabetes SMART, Breathe SMART, HospitalReadmission, and Initial Health Assessment) with a single program that aligns measures with evidence-based standards of care and will report gaps in care that are <u>actionable</u> for the practice. All measures included in the program encourage increased utilization of treatment, screening and preventive health services which will improve the health status of CenCal Health members. The new P4P program will include twelve clinical measures that will quantify PCP performance:

- A. Behavioral Health Care
 - 1. Antidepressant Medication Management Acute Treatment
 - 2. Antidepressant Medication Management Continuing Treatment
- B. Diabetes Care
 - 3. HbA1c Testing
 - 4. Retinal Eye Exams
- C. Pediatric Care
 - 5. Immunizations for Adolescents
 - 6. Well Child Visits in the first 30 Months of Life
 - 7. Child and Adolescent Well-Care visits
 - 8. Lead Screening in Children
- D. Respiratory Care
 - 9. Asthma Medication Ratio
- F. Women's Health Care
 - 10. Breast Cancer Screening
 - 11. Cervical Cancer Screening
 - 12. Chlamydia Screening in Women

The P4P program is funded by CenCal Health, as well as being defined as a withheld percentage of a PCP's monthly capitation. With the new QCIP program, PCPs are required to attest to their capitation withhold percentage on an annual basis in advance of the reporting year. PCP performance will be calculated and reported for each clinical measure and all combined clinical measures and will be expressed using a 5-star performance scale, similar to the current Gaps in Care program.

CenCal Health will be calculating the clinical performance and reporting it to PCPs on a monthly basis. This reporting will include all information necessary for our PCPs to take action to complete member outreach and improve their performance. Incentive payments earned by PCPs will be calculated and distributed on a quarterly basis.
