Dear Shelley,

Several weeks ago the Trump Administration released plans to hold 6 new offshore oil and gas leasing sales off of the Central California coast and the southern California coast starting in 2027.

Locally more than a hundred community members showed up last month at the Santa Barbara County Board of Supervisors hearing urging them to deny Sable Offshore permits for oil and gas facilities including the very pipeline that caused the catastrophic oil spill ten years ago on the Gaviota Coast.

The **Supervisors voted 4-1** to **deny the permits** and ordered staff to instead prepare **"Findings of Denial"** for a vote taking place on **Tues., Dec. 16.**

We need your voice at this critical final hearing on Dec. 16 starting at 9 am to urge the Board to make the final vote to deny the transfer of these permits to Sable.

We are grateful that **Supervisors Capps, Lee, Hartmann, and Lavagnino** listened to the community and expressed their concerns about Sable last month.

Dec. 16 is our chance to finish what we started and make sure the **Board** denies Sable's transfers once and for all.

Subject: Deny Sable Offshore permits

TALKING POINTS:

- The Board of Supervisors must deny Sable's application to transfer permits for the Santa Ynez Unit, Las Flores Pipelines, and onshore processing facilities.
- Sable's record makes clear the company does not have the skills, training, or financial resources to operate these dangerous oil facilities.

For example: The California Coastal Commission fined Sable a record \$18 million penalty;

The state Attorney General filed a lawsuit accusing Sable of illegally discharging waste into streams and habitats;

The District Attorney filed 21 criminal charges against the company, including five felonies; and

The State Fire Marshal sent Sable a notice regarding noncompliance with the State Waiver requirements for the pipelines.

- Sable has not shown that it has the financial capacity to cleanup an oil spill or abandon the facilities.

Dear Members of the Board,

In addition to my prior comment, I would like to add the following note.

The upcoming hearing of the California State Lands Commission (CSLC) to consider letting Chevron walk away from their oil and gas lease obligations without cleaning up their mess on the ocean floor, serves as an extremely timely reminder of why you should DENY Sable's permit transfer request.

Time and time again, oil companies receive below market value leases, and then find ways to transfer any spill or shutdown clean up costs to taxpayers. We simple cannot afford to let this happen in the future. Your vote to DENY the transfer is an important step in the right direction.

Additionally, while this is somewhat of a tangent, the upcoming CSLC hearing brings to mind another idea for the future: have any oil and gas company that wants to do business in Santa Barbara place an amount equal to the most extreme clean up costs into escrow in the County's name, so that taxpayers don't get stuck with the bill again.

I again urge you to DENY Sable's permit transfer request, and thank you for your consideration of this important issue.

Dear Members of the Board:

I am writing today to urge you to VOTE NO ON THE TRANSFER OF PERMITS FROM EXXON TO SABLE.

By way of background, I am a local resident who first hand experienced the damaging impacts of the Refugio Oil Spill, personally witnessing massive damage to the coastal environment from just north of Refugio all the way down the coast. I watched as the oil spewed into the ocean, saw birds covered in oil, and saw remnants of this spill both in ocean waters and along various beaches from Refugio to El

Capitan to Naples for YEARS after the last spill. That spill should serve as a strong reminder of the dangers these pipelines pose.

It has therefore been deeply disturbing to personally witness the rogue work of Sable, particularly over the past year+. I frequently drive the 101 along the Gaviota coast, both for work and for recreation, and I have personally observed their teams working in the area, often in the early morning hours and on weekends, seemingly in an attempt to hide their actions. Sable's violations of the Water Code and RWQCB's directives are part of a broader pattern of disregarding state law and regulation, and this should totally disqualify them from operating in our County.

Sable's conduct speaks for itself: they have brazenly broken County and State laws, and shown a tremendous level of disregard for the local community and the rule of law. Therefore, the proposed transfer from Exxon to Sable should be blocked.
