That the Board of Supervisors:

- a) Approve and authorize the Chair to execute the attached First Amendment to the Agreement with Drake Haglan & Associates 11060 White Rock Road, Suite 200, Rancho Cordova, CA 95670 (not a local vendor), for roadway and structural design services for the Fernald Point Lane Bridge 51C-137 Project, Federal Projects BRLO-5951 (141), County Project No. 862330 to extend the term for an additional 2-years; and
- b) Find that pursuant to State California Environmental Quality Act Guidelines Section 15162, no substantial changes are proposed, and no new information of substantial importance has come to light regarding environmental effects of the project or of the sufficiency or feasibility of mitigation measures, and therefore the proposed actions are within the scope of the Mitigated Negative Declaration (15NGD-00000-00005) and Mitigation Monitoring Program adopted by the Board upon approval of the project on June 21, 2016, and that therefore no new environmental document is required.

Summary Text:

This item is on the agenda in order to amend the agreement with Drake Haglan & Associates to extend the term to complete roadway and structural design services. The contract, which was executed by your

Board on August 19, 2014, is set to expire on December 31, 2016. The attached First Amendment extends the time period to December 31, 2018, which is two years from the agreement's original end date, with no additional costs to the County.

Background:

Fernald Point Lane (FPL) Bridge 51C-137 is located at the eastern terminus of FPL at Romero Creek. This project will replace the existing bridge with a new bridge (No. 51C-0362) and provide improved fish passage elements at the northern end of this concrete lined channel.

Extending this contract will allow for continued roadway and structural design to complete the plans, specifications, and estimate. Work on these parts of the contract was delayed while the project team worked to incorporate fish passage elements into the project required by regulatory agencies to approve permits for the bridge project.

On June 21, 2016, your Board approved the project and the California Environmental Quality Act (CEQA) Mitigated Negative Declaration. The current project consists of replacing the existing bridge with one designed to meet the AASHTO minimum Standard of 22 feet (two 9' travel lanes and two 2' shoulders).

There is no cost associated with the time extension amendment for this project. The cost for the original contract scope is 100% funded by the Highway Bridge Program with toll credits. The funds are budgeted in Dept. 054, Fund 0017, Org. Unit 0600, Program 2820, and Account 7460.
